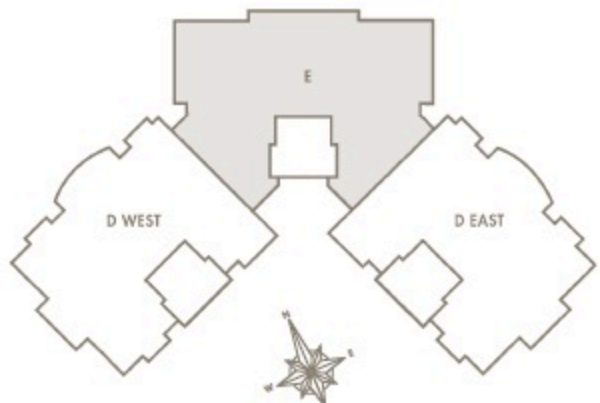

THE "ARCHITECTURAL METHOD" MEASURES A UNIT TO THE OUTSIDE FINISHED SURFACE OF EXTERIOR WALLS AND INCLUDES PORTIONS OF THE COMMON ELEMENTS OF THE CONDOMINIUM. THE SQUARE FOOTAGE DERIVED USING THE ARCHITECTURAL METHOD IS GREATER THAN THE SQUARE FOOTAGE DERIVED USING THE PARAMETRICAL METHOD. THE SQUARE FOOTAGE OF THE UNIT USING THE ARCHITECTURAL METHOD IS SET FORTH ABOVE AND IS INCLUDED IN SALES MATERIALS TO ALLOW A PROSPECTIVE BUYER TO COMPARE THE SQUARE FOOTAGE OF THE UNITS WITH UNITS IN OTHER CONDOMINIUM PROJECTS THAT UTILIZE THE ARCHITECTURAL METHOD. THE PARAMETRICAL METHOD IS USED IN THE LEGAL DOCUMENTS FOR PALAZZO DEL SOL AT FISHER ISLAND, A CONDOMINIUM AND YIELDS A SQUARE FOOTAGE OF 9,826 SQUARE FEET.
